Herewith we transfer the approval as "BMW Longlife-12 FE" oil, given for engine oil code "65646" to the Reblend oil "WOLF OFFICIALTECH 0W30 SP"¹. SAE 0W-30 (oil code confidential) of WOLF OIL CORPORATION N.V." Consequently it is approved according to our release procedure for BMW Longlife engine oils (9th edition, November 2018) for the usage in BMW engines operating in compliance with our operating fluids manual.

This confirmation is valid for two years beginning with the date of this letter (provided that the reference formulation is still approved) and can be extended no more than two times for a maximum of two years in each case. Prolongations have to be requested within BFAS (BMW Fluid Approval System), the extension date can be taken from BFAS, reference EOA-RBL-2021-02192.

Engine oils produced using the code or brand names mentioned in this letter of confirmation have to comply with the tested oil sample in every respect. Any proposed alteration or modification to the lubricant has to be supplied in writing to the BMW department "Entwicklung Antrieb" whereby a new approval may be granted.
